# ARTICLES OF INCORPORATION OF FLORIDA PULP AND PAPER MANUFACTURERS ASSOCIATION, INC.

### A FLORIDA NONPROFIT CORPORATION

### ARTICLE I.

### Name

The name of this corporation is Florida Pulp and Paper Manufacturers Association, Inc.

### ARTICLE II.

### Duration

The duration of this corporation shall be perpetual, commencing with the filing of these Articles with the Department of State of the State of Florida.

### ARTICLE III.

### **Purposes**

The general purpose of this corporation is to promote the common business interests of persons engaged in the pulp and paper industry in the State of Florida. The corporation may undertake any action necessary to further this general purpose including, without limiting the generality of the foregoing, monitoring and influencing legislative, quasi-legislative, judicial, and quasi-judicial activities and any other governmental action affecting, or which may affect, the business of the members. The corporation shall not, as its primary activity, engage in a regular business of a kind ordinarily carried on for profit.

### ARTICLE IV.

### **Dedication of Assets**

The property of this corporation is irrevocably dedicated to its purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer, or

member thereof, or to the benefit of any private individual; provided that, upon dissolution or final liquidation the corporation may make distribution to its members as permitted by the court having jurisdiction thereof and no such liquidating payment or distribution shall be deemed to be a dividend or a distribution of income.

### ARTICLE V.

### Membership

There shall be two classes of membership; voting and nonvoting.

All persons engaged as an owner of a business in the manufacture of pulp, paper, paperboard or forest products for sale of for other processing and engaged in such business in the State of Florida, paying dues and fees as provided in the bylaws, and agreeing to be bound by the articles and the bylaws, and by such rules and regulations as the Board of Directors may from time to time adopt, are eligible for voting membership.

All persons engaged in the manufacture of pulp, paper, paperboard or forest products for sale or further processing but not engaged in such business in the State of Florida, paying dues and fees as provided in the bylaws, and agreeing to be bound by the articles and the bylaws, and by such rules and regulations as the Board of Directors may from time to time adopt, shall be eligible for nonvoting membership.

Membership (voting and nonvoting) shall not be transferable. The Board of Directors shall from time to time prescribe the form and manner in which application may be made for membership.

### ARTICLE VI.
