ARTICLES OF INCORPORATION
OF
FLORIDA ASSOCIATION FOR THE TREATMENT OF SEXUAL ABUSERS, INC.

FLORIDA NONPROFIT CORPORATION

ARTICLE 1: Corporate Name. The name of the corporation is Florida Association for the Treatment of Sexual Abusers, Inc. Its principal office, registered office and mailing address is 1560 Matthew Drive, Suite J, Fort Myers, Florida 33907.

ARTICLE 2: Corporate Purpose. This nonprofit corporation is organized to promote the advancement of professional standards and practices in the field of sexual offenders evaluation and treatment and to provide such other services as may be appropriate under law.

ARTICLE 3: Duration. The term of existence of the corporation is perpetual.

ARTICLE 4: Board of Directors. The powers of this corporation shall be exercised, its properties controlled, and its affairs conducted by a Board of Directors. The manner in which Directors are elected shall be specified in the bylaws. The initial number of Directors shall be three and may be changed as provided by the bylaws. The names and addresses of the initial members of the Board of Directors are as follows:

ARTICLE 5: Corporate Officers. Officers' positions and the procedure for electing them shall be specified in the bylaws.

ARTICLE 6: Membership. This corporation may have several classes of members, as determined by the bylaws. Qualification for membership, including the amount of dues, shall be established by the bylaws.

ARTICLE 7: Incorporator, Registered Agent, and Resident Office. The name of Incorporator and Registered Agent of this corporation, his address, and the address of the resident office is:


