
First: Amendments Adopted is #N96000000422 is the addition of (3) updated Articles, all updated articles are to remain as is.

**Article X**

Notwithstanding any other provisions of these Articles, the organization shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal income tax as an organization described in Section 501 C 3 of the Internal Revenue Code (or corresponding Section of any future Federal tax Code.

**Article XI**

Upon the dissolution and winding up of this organization after paying or adequately providing for the debts and obligations of the organization. The remaining assets shall be distributed to a nonprofit fund, foundation or corporation organized and operated exclusively for the purpose specified in Section 501 C 3 of the Internal Revenue Code and has established it tax-exempt status under that Section.




