ARTICLE I

The name of this corporation is Orlando G.O.H., Inc.

ARTICLE II

ARTICLE III

Purpose

This is a nonprofit corporation, organized solely for general promotion of safe, recreational motorcycling, social and charitable purposes pursuant to the Florida Corporations Not for Profit Law set forth in Section 617 of the Florida Statutes.

ARTICLE IV

Manner of election of directors

The Corporation shall be managed by a Board of Directors. The number of the offices constituting the initial Board of Directors of the corporation is four, and the names and addresses of the persons who are to serve as the initial directors are:

Subject to the foregoing, the number of the Board of Directors may be fixed from time to time by action of the members or of the Directors. No decrease shall shorten the term of any director then in office.
