# PURPOSE.

#### POWERS

- 3.1 Common Law and Statutory Powers. The Association shall have all of the powers reasonably necessary to implement its purpose, and to enforce by legal means the provisions of the Declaration, these Articles, the By-Laws and the Rules and Regulations of the Association.
- 3.2 <u>Limitations.</u> The powers of the Association shall be subject to and be exercised in accordance with the provisions of the Declaration.
- 3.3 <u>Funds and Title to Properties.</u> All funds and title to all properties acquired by the Association and the proceeds thereof shall be held only for the benefit of the Members in accordance with the provisions of the Declaration.

#### ARTICLE IV

#### BOARD OF DIRECTORS

The affairs of the Association shall be managed by a Board of Directors. Until such time as the Developer relinquishes control of the Association, as described in the Declaration, and By-Laws, the Developer shall have the right to appoint a majority of the members of the Board of Directors. Further, no Director appointed by the Developer need be a Member. Sowever, all Directors elected by Members other than the Developer must be Members. The initial Board shall consist of three (3) Directors, whom shall be appointed by the Developer. The Developer shall be entitled, at may time and from time to time, to remove or replace any Director originally appointed by the Developer. The Developer may waive or relinquish, in whole or in part, any of its rights to appoint anyone or more of the Directors it is entitled to appoint. #### ARTICLE V

#### Indomnification of Officers and Directors

Every Director and Officer of the Association shall be indomnified by the Association against all expenses and liability, including attorneys' foor, reasonably incurred by or imposed upon him in connection with any proceeding to which he may be a party or in which he may become involved by reason of his being or having been a director or officer, whether or not he is a director or officer at the time such expenses are incurred, except in such cases where the director or officer is adjudged guilty of willful misfeasance or malfoasance in the performance of his duties, provided however, that in the event of any claim for reimburgement or indomnification horoundor based upon a settlement by the director or officer seeking such reimbursement or indemnification, the indomnification herein shall apply only if the Board approves such settlement and reimbursement as being in the best interest of the Association. The foregoing right of indomnification shall be in addition to but not exclusive of all other rights to which such officer or director may be entitled. This obligation shall be funded by directors and officers liability insurance as is reasonably available wherever possible, which insurance shall be a Common Expense of the Members.

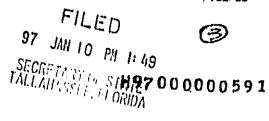
