In the course of attempting to file an Amendment to the Articles of Incorporation for the above-referenced corporation, it has come to my attention that the corporation has been administratively dissolved due to failure to file an annual report.

Although we represent GLB Youth of Miami, Inc. in its application for tax exempt status, the corporate officers have chosen to handle items such as the annual report. Dale Ayres, President, assures me that he never received the annual report typically sent by your office in the spring of each year. Our office, which does a significant amount of corporate work, has found this to be the case with several other corporate annual reports: they do not all get sent out.

This is a not-for-profit corporation. Asking it to pay \$236.25 in order to reinstate is particularly unfair in light of the fact that the corporate annual report was never received. Please note that, while it is true that the corporate mailing address changed in February of this year, all of their mail was forwarded without incident until May, 1997.
