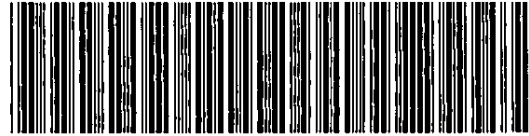

DIMINISH THE WORKS OF THE FLESH IN THEIR LIVES, THROUGH THE POWER OF THE HOLY SPIRIT AND OUR LORD JESUS CHRIST. THIS CHURCH SHALL FUNCTION

RECOGNIZING THE OPERATION OF THE SPIRITUAL GIFTS OF THE SPIRIT OF GOD. WE DO ACKNOWLEDGE THAT THE GREATEST OF ALL SPIRITUAL GIFTS IS CHARITY.

ARTICLE III THIS CORPORATION HAS ZERO TOLERANCE FOR ANY SEXUAL MISCONDUCT AND WILL NOT KNOWINGLY SUPPORT, ENCOURAGE, TOLERATE, PARTICIPATE,

FORM NOR MAINTAIN ALLIANCES WITH ANY PERSONS OR ORGANIZATIONS WHICH ENGAGE AND/OR PRACTICE THE ACTIVITIES LISTED IN THE FOLLOWING SCRIPTURES

OF THE ORIGINAL (1611) KING JAMES VERSION OF THE HOLY BIBLE, THOSE BEING: LEVITICUS 18:4-30 (HOMOSEXUALITY AND OTHER SEXUAL PERVERSIONS);

ROMANS 1:26-28 (WOMEN AND MEN LEAVING NATURAL AFFECTIONS); DEUTERONOMY 18:10-14 (WITCHCRAFT AND OCCULT PRACTICES); AND
