Additional Article:

The Community Church of Praise and Deliverance ("CCOPD" and as further referred to as "The Church"), its building, land and administration, shall perpetually be designated as a church and edifice, dedicated to the worship of Jehovah, Elohim, Rapha God. The primary purpose shall perpetually be for the 'ministry of reconciliation of men back to the Father through Jesus Christ Our Lord and Savior' (2 Cor. 5:18). The foundational tenets, principles, protocols and disciplines shall perpetually be based on and derived from the King James Version of the Holy Bible. For all intents and uses described in this document, the definition of "Perpetual" shall mean, continual and enduring forever, without intermission or interruption.

The Church, built and established by the founder Pastor Joseph Talbott Thompson and then bequeathed to Bishop Joseph Talbott Ingraham (his grandson), shall be according to his wishes, the perpetual legacy of the children and heirs of Bishop Joseph Talbott Ingraham. The operation of the Church shall be governed by an incorporation Board of Directors and Members of the Board, which shall perpetually be comprised of the established children and heirs of Joseph Talbott Ingraham.

The pastor to date (January 17, 2019), Sheila E. Ingraham (daughter of Bishop J.T. Ingraham), shall remain pastor, until such time as her life deviates or violates the tenets, principles, protocols and disciplines of the Holy Bible or if she is mentally incompetent, physically incapacitated or upon her death.

All succeeding pastors will be derived from the children and heirs of Bishop J.T. Ingraham, as candidates are found "worthy and capable", they shall be voted into the office of pastor by the operational Board. The term "worthy and capable", shall be defined as their personal and spiritual lives exhibit and display the tenets, principles, protocols and disciplines of the Holy Bible. If the Board finds none whose life is "worthy and capable", then the Board shall seek a pastor and spiritual leader from among the full Body of Christ to be voted into the office of pastor of the church.

As per the desires of the original church founder and builder, Pastor Joseph Talbott Thompson and per the final Will and Testament of Bishop Joseph Talbott Ingraham, the church and all of its holdings, to include; the building, land and administration is in governance and ownership of the children and heirs through their designated membership as Board Members and Board of Directors of the church.
