ARTICLES OF INCORPORATION FILED

OUTREACH FOR YOUTH II, xx+10, 96 MAY 13 MM 31 32

The undersigned, acting as incorporators(s) of a corporation pursuant to Chapter 617, 17 Florida Statues, adopt(s) the following Articles of Incorporation:

ARTICLE I - Name

The name of the corporation shall be: Outreach for Youth II, Inc.

ARTICLE II - Principal place of business and mailing address

The principal place of business and the mailing address of this corporation shall be: 1097 ANNIE MATTOX AVENUE, LAKE CITY, FL 32055.

ARTICLE III - Purpose(s)

The specific purpose for which the corporation is organized is(are):

- (1) To operate exclusively for religious, charitable, scientific, or any purposes, and any other purpose described in Section 501(c)(3) of the Internal Revenue Code of 1986, and primarily targeting the problems of community deterioration and juvenile delinquency by providing positive and motivating activities/programs for youth 18 and under; provided, however, that no part of the corporation's income or principal shall inure to the benefit of any private shareholder or individual, and no substantial part of the activities of which is carrying on propaganda or otherwise attempting to influence legislation or participating in or intervening in (including the publishing and distributing of statements) any political campaign on behalf of any candidate for public office.
- (2) No part of the net earnings of the corporation shall inure to the benefit of or be distributed to any member, director, trustee, officer of the corporation, or any affiliated organization, or any private individual (except that reasonable compensation may be paid for services rendered to or for the corporation in connection with one or more of its purposes) and no member, trustee, officer of the corporation, or an affiliated organizations or any private individual shall be entitled to share in the distribution of any of the corporation's assets on dissolution of the corporation.
- (3) No part of the activities of the corporation shall involve carrying on propaganda or otherwise attempting to influence legislation or participating in or intervening (including publishing or distributing of statements) in any political campaign on behalf of any candidate for public off; nor shall the corporation engage in any activities that are unlawful under applicable federal, state, or local laws.

(4) Upon the dissolution of the corporation, the Board of Directors shall, after paying or making provisions for the payment of all of the liabilities of the corporation, distribute all assets of the corporation exclusively to selected community betterment organizations which are described in Section 509(a)(1) or Section 509(a)(2) of the Internal Revenue Code of 1986 and which at the time of dissolution of this corporation, then said assets remaining after paying or making provisions for the payment of liabilities of the corporation shall be distributed exclusively for the purposes of the corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational, religious, or scientific purposes as shall at the time qualify as an exempt organization or organizations under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provisions of any future United States Internal Revenue law), and as the Board of Directors shall determine.

ARTICLE IV - Manner of election of directors

The manner in which the directors are elected or appointed is as follows:

- Section 1. The corporation shall have four directors initially. The number of Directors may be increased, or decreased, from time to time, by the by-laws.
- Section 2. The board of Directors shall be members of the corporation.
- Section 3. Members of the Board of Directors shall be elected and hold office in accordance with the by-laws.

ARTICLE V - Limitation of corporate powers

The corporate powers of this corporation are as provided in section 167.0302, Florida Statutes, unless limited as follows:

Subject to the express limitation that the corporation shall neither have nor exercise any power, nor shall it engage directly or indirectly in any activity, that would invalidate its status (a) as a corporation which is exempt from federal income taxation as an organization described in Section 501(c)(3) of the Internal Revenue code of 1986, or (b) as a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue code of 1986, the corporation shall have and possess all powers and rights conferred upon corporations by the Florida Nonprofit Corporation Act and any enlargement of such powers conferred by subsequent exercise all powers and rights not otherwise denied nonprofit corporations by the laws of the State of Florida, as are necessary, suitable, proper, convenient, or expedient to the attainment of the purposes set forth in Article II herein.
