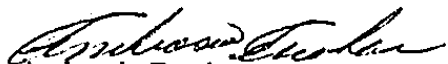

NONPROFIT ARTICLES OF INCORPORATION

IGLESIA DEFENSORES DE LA FE ROSA DE SARON, INC. (Defenders of Faith Rose of Sharon)

The undersigned incorporators, for the purpose of forming a nonprofit corporation under the section 617.0202, Florida Statutes, hereby adopt the following Articles of Incorporation:

ARTICLE I- NAME

The name of the Corporation shall be:

IGLESIA DEFENSORES DE LA FE ROSA DE SARON, INC.

ARTICLE - II

The Non-profit Corporation shall have perpetual existence.

ARTICLE - III

The specific purpose for which the corporation is organized are:

- A. To organize and operate a Christian church with the purpose of minister and to preach the word of God (The Gospel) to the general public. To create different ministries with the purpose of helping the community in general. To receive donations of any kind with the purpose of spread the Gospel to the general public.

- E. To preach the Gospel in television, radio programs, crusades around the world.

- G. To do all and everything necessary and proper for the accomplishment of any of the purposes or the attaining of any of the objectives or the furthermore of any of the purposes enumerated in these Articles of Incorporation or any amendment hereof necessary and incidental to the protection and benefit of the corporation, and, in general, either alone or in association with other corporations, firms, or individuals, to carry on any lawful manner, pursuit necessary or incidental to the accomplishment of the purposes or objects of this corporation.

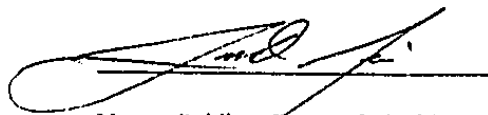

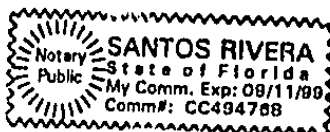
