

ARTICLES OF INCORPORATION

OF



HIDDEN LAKES MEN'S GOLF ASSOCIATION, INC. (A Florida Not For Profit Corporation)

ARTICLE 1 CORPORATE NAME, PRINCIPAL OFFICE AND MAILING ADDRESS

The name of this Corporation shall be: **IIIDDEN** LAKES MEN'S GOLF ASSOCIATION, INC., with its principal office located at 35 Fairgreen Avenue, New Smyrna Beach, Florida 32168 and its corporate mailing address being the same.

ARTICLE II PURPOSE

The purpose for which this corporation is organized is to promote the playing and enjoyment of golf and the social activities customarily incident thereto, and in general to enjoy all of the powers and privileges of a golf association as well as all powers and privileges conferred upon corporations not for profit under the laws of the State of Florida.

ARTICLE III NONSTOCK CORPORATION

This corporation is organized upon a nonstock basis and shall not issue shares of stock. No dividend shall be paid, and no part of the income of the corporation shall be distributed to its members, directors, or officers.

ARTICLE IV TERM OF EXISTENCE

This Corporation shall have perpetual existence, commencing upon filing of these Articles.

ARTICLEV REGISTERED AGENT AND INITIAL REGISTERED OFFICE

ARTICLE VI MEMBERSHIP

The qualifications for members and the manner of their admission, the different classes of membership, the voting and other rights and privileges of members and the termination of membership, shall be as regulated by the by-laws.

ARTICLE VII BOARD OF DIRECTORS

This Corporation shall have nine (9) directors initially. The number of directors may be increased or diminished from time to time by By-Laws adopted by the Board of Directors, but shall never be less than three (3).
