ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation pursuant to chapter 617, Florida Statutes 20 adopts the following Articles of Incorporation:

The name of the corporation shall be Tallahassee Area Foster Parent Association, Inc., (hereinafter "ASSOCIATION").

ARTICLE II Principal Business Location and Mailing Address

The principal business location of the ASSOCIATION shall be Leon County, State of Florida. Its mailing address shall be PO Box 4162, Tallahassee FL 32315.

ARTICLE III Purposes

The ASSOCIATION is organized are exclusively for charitable and educational purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, including, (1) for such purposes, the making of making distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code; and (2) uniting foster parents in the service of children; educating the community and foster parents about foster care issues; and providing for the welfare and education of foster children.

ARTICLE IV Manner of Election of Directors

Directors shall be elected in the manner established by the ASSOCIATION Bylaws.

ARTICLE V **Limitation of Corporate Powers**

The ASSOCIATION's corporate powers are as provided in section 617.302, Florida Statutes, as it may be amended from time to time, except the it may not exercise any powers inconsistent with section 501(e)(3) of the Internal Revenue Code. No part of the net earnings of the ASSOCIATION shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the ASSOCIATION shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Three above. No substantial part of the activities of the ASSOCIATION shall be the carrying on of propaganda, or otherwise attempting

to influence legislation, and the ASSOCIATION shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the ASSOCIATION shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)93) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE VI Initial Registered Agent and Street Address

The name and address of the initial registered agent is: Rosemary N. Palmer, 5260 Pimlico Drive, Tallahassee FL 32308.

ARTICLE VII

Ken Hayward of 1827 Mayfair Roac Tallahassee, FL 32303 is the incorporator for these Articles of Incorporation.

ARTICLE VIII Distribution of Assets at Dissolution

Upon dissolution of the ASSOCIATION, assets shall be distributed for one or more exempt purposes within the meaning of section (501(e)(3) of the Internal Revenue Code, or any corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the ASSOCIATION is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
