OF

TURTLE BEACH RESORT COMMUNITY ASSOCIATION, INC.

The undersigned, by these Articles associate themselves for the purpose of forming a corporation not for profit under Chapter 617, Florida Statutes, and cortify as follows:

ARTICLE I

NAME AND ADDRESS. The name of the corporation shall be "Turtle Beach Resort Community Association, Inc." (the "Association") and the street address of its Enitial principal office is 55 Nature Way, Santa Rosa Beach, Florida 32458.

ARTICLE II

PURPOSE. The purpose for which the Association is organized is as follows:

- (1) To provide an entity pursuant to the Condominium Act, which is Chapter 718, Florida Statutes, 1995, for the operation, management, maintenance and control of one or more condominiums and 4 residential single family lots or units as may be from time to time submitted to its jurisdiction, and
- (2) To provide an entity for the operation, management, maintenance and control of one or more developments other than condominiums as may be from time to time submitted to its jurisdiction, and
- (3) To provide an entity for the operation, management, maintenance and control of all or such parts thereof of the real property located in Walton County, Florida, described on Exhibit A hereto, together with the recreational, greenspace, ingress and egress, parking, utilities and other related amenities as may be from time to time constructed thereon (the "Community Property"). Pursuant to the Community Property Agreement entered into by and between the Association and Turtle Beach of Northwest Florida, Inc., a Florida corporation (the "Developer"), the Association shall hold the use rights and privileges granted by the Community property Agreement in trust for the benefit of the unit pages of such condominiums and lot owners of such subdivisions as may be,

from time to time, submitted to the jurisdiction of the Association, and upon termination of the Community Property Agreement, the Association will receive fee simple title to the Community Property from the Developer pursuant to the covenants and agreements of the Community Property Agreement. The Association shall make no distribution of Income to its members, directors or officers.

ARTICLE III

SUBMISSION TO JURISDICTION. A condominium shall be deemed to be submitted to the jurisdiction of the Association if the declaration of condominium of the condominium provides that the operation of the condominium shall be by the Association. A subdivision shall be deemed to be submitted to the jurisdiction of the Association if the declaration of covenants and restrictions of the subdivision provides that the operation of the subdivision shall be by the Association.

ARTICLE IV

<u>POWERS</u>. The powers of the Association shall include and be governed by the following provisions:

- (A) The Association shall have all the common law and statutory powers of a corporation not for profit not in conflict with the terms of these Articles or the declaration of condominium of any condominium operated by the Association or the declaration of covenants and restrictions of any subdivision operated by the Association.
- (B) The Association shall have all the powers and duties set forth in these Articles and the declaration of condominium of any condominium operated by the Association and in the Condominium Act except where the Act allows limitations by these Articles and in the declaration of covenants and restrictions of any subdivision operated by the Association or any such declaration and all of the powers and duties reasonably necessary to operate any condominiums or subdivisions operated by the Association and as it may be amended from time to time, including but not limited to the following:

- (1) To hold title to and own fee simple or other leaser interest in real, personal or mixed property, wherever situated, including units in any condominium or lots in any subdivision operated by the Association, and to lease, mortgage and convey same.
- (2) To make and collect assessments against the members as unit or lot owners to defray the costs, expenses and losses of any condominium or any subdivision operated by the Association or served by the Community Property or any costs, expenses or losses of the Association related to the Community Property and to defray the costs, expenses and losses of any other business, enterprise, venture or property interest of the Association.
- (3) To use the proceeds of the assessments in the exercise of these powers and duties.
- (4) To maintain, repair, replace and operate the property of any condominium or any subdivision operated by the Appociation, the Community Property or any other property of the Association.
- (5) To purchase insurance upon the property of any condominium or any subdivision operated by the Association, the Community Property or any other property of the Association and insurance for the protection of the Association and its members.
- (6) To reconstruct improvements after casualty and to further improve the property of any condominium or any subdivision operated by the Association, the Community Property or any other property of the Association.
- (7) To make and amend reasonable regulations respecting the use of the property of any condominium or any subdivision operated by the Association, the Community Property or the other property of the Association.
- (8) To enforce by legal means the provisions of the Condominium Act, the declaration of condominium of any condominium operated by the Association, the declaration of covenants and

restrictions of any subdivision operated by the Association, these Articles, the By-Laws of the Association, the Community Property Agreement, and regulations for the use of the property of any condominium or subdivision operated by the Association, the Community Property or the other property of the Association.

- (9) To contract for the management of the Association, the Community Property, any condominium or any subdivision operated by the Association or any portion thereof, and to delegate to such contractor all powers and duties of the Association except such as are specifically required by the declaration of condominium of any condominium or the declaration of covenants and restrictions of any subdivision operated by the Association to have approval of the Board of Directors or the membership of the Association.
- (10) To contract with the Daveloper, its successors and assigns, and any of the partners of the Daveloper, their officers, directors, partners or shareholders.
- (11) To acquire fee simple title to, to lease, acquire memberships or acquire other possessory or use interest in and to operate lands and facilities, including but not limited to the Community Property, whether or not contiguous to the lands of any condominium or any subdivision operated by the Association, intended to provide for the enjoyment, recreation or other use or benefit of the members, or a substantial number of the members, of the Association.
- (12) To determine which persons shall be entitled to use the Community Property including all fees, charges and other terms and conditions relating to such use and to enter into such agreements as may be necessary or incidental theceto.
- (13) To employ personnel to personne the services required for the proper operation, management maintenance or control of the Association, any condominium or any subdivision operated by the Association, the Community Property, or any other property of the Association.

- (14) To hire attorneys or other professionals for the purpose of bringing legal action or enforcing rights in the name of and on behalf of the members of the Association where such actions or rights are common to all members, or a substantial number of the members; and to bring such action in the name of and on behalf of the members.
- (C) All funds and the title of all properties acquired by the Association and their proceeds shall be neld in trust for the members in accordance with the provisions of the declaration of condominium of any condominium or the declaration of covenants and restrictions of any subdivision operated by the Association, the Community Property Agreement and the By-Laws of the Association.

ARTICLE V

MEMBERS.

- (A) The members of the Association shall consist of all of the record owners of units in such condominiums or lots in such subdivisions as may, from time to time, be submitted to the jurisdiction of the Association and after termination of any such condominium or subdivision shall consist of those who are members at the time of such termination and their successors and assigns.
- (B) A change of membership in the Association shall be established by recording in the public records of Walton County, Florida, a deed or other instrument establishing a record title to a unit in any condominium or a lot in any subdivision operated by the Association and the delivery to the Association of a certified copy of such instrument. The owner designated by such instrument thus becomes a member of the Association and the membership of the prior owner is terminated.
- (C) The share of a member in the funds or assets of the Association cannot be assigned, hypothecated or transferred in any manner except as an appurtenance to his unit or lot.
- (D) The owner of each unit in a condominium or lot in a subdivision operated by the Association shall be entitled to at least one (1) vote as a member of the Association. The exact

number of votes to be cast and the manner of exercising voting rights shall be determined by the By-Laws of the Association.

ARTICLE VI

DIRECTORS.

(A) The affairs of the Association will be managed by a goard consisting of not less than three (3) nor more than seven (7) directors who shall be designated or elected as hereinafter set forth. Directors need not be members of the Association.

(B) The names and addresses of the members of the first Board of Directors who have been designated as such by the Developer and who shall hold office until their successors are designated or elected as herein provided and have qualified or until removed as herein provided are as follows:

Until unit owners other than the Developer are entitled to elect members of the Board of Directors, the members of the Board of Directors shall be designated by the Developer and may be changed from time to time as the Developer, in its sole discretion, may determine.

- entitled to elect at least a majority of the Board of Directors, the Board of Directors shall consist of three (3) members. The first election of Directors shall not be held until required by the Condominium Act, including Section 718.301(1)(a)-(e) thereof, or until the Developer elects to terminate its control of the Association. The provisions of Section 718.301(1)(a)-(e) are set forth in Article (D) below.
- (D) Section 718.301(1)(a-e) of the Condominium Act provides as follows:

"718.301 Transfer of association control.

- (1) When unit owners other than the developer own 15 percent or more of the units in a condominium that will be operated ultimately by an association, the unit owners other than the developer shall be entitled to elect no less than one-third of the members of the board of administration of the association. Unit owners other than the developer are entitled to elect not less than a majority of the members of the board of administration of an association:
 - (a) Three years after 50 percent of the units that will be operated ultimately by the association have been conveyed to purchasers;
 - (b) Three months after 90 percent of the units that will be operated ultimately by the association have been conveyed to purchasers;
 - (c) When all the units that will be operated ultimately by the association have been completed one of them have been urchasers, and none of the others osing offered for sale by the develops: in the ordinary course of business;
 - (d) When some of the units have been conveyed to purchasers and none of the others are being constructed or offered for sale by the developer in the ordinary course of business; or
 - (e) Seven years after recordation of the declaration of condominium, or, in the case of an association which may ultimately operate more than one condominium, 7 years after recordation of the declaration for the first condominium it operates, or, in the case of an association operating a phase condominium created pursuant to \$718.403, 7 years after recordation of the declaration creating the initial phase, whichever occurs first. The developer is entitled to elect at least one member of the board of administration of an association as long as the developer holds for male in the ordinary course of business at least 5 percent, in condominiums with fewer than 500 units, and 2 percent, in condominiums with fewer than 500 units, and 2 percent, in condominiums with more than 500 units, of the units in a condominium operated by the association. Following the time the developer relinquishes control of the association, the developer may exercise the right to vote any developer owned units in the same manner as any other unit owner except for purposes of reacquiring control of the association or selecting the majority members of the board of administration."

"(E) Reginning with the election at which unit owners other than the Developer are entitled to elect at least a majority of the Board of Directors the affairs of the Association will be managed by a Board consisting of moven (7) directors and shall include two (2) classes of directors as follows:

(1) Class A Directors. There shall be one (1) Class A Director for the residential single family lots elected solely by the unit owners of Turtle Beach Condominiums and one (1) Class A Director for Turtle Beach Resort elected solely by the lot owners of Turtle Beach Resort.

(2) At Large Directors. There shall be five (5) directors elected at large by the members of the Association (that is, all of the unit owners of Turtle Beach Condominiums and all of the lot owners of Turtle Beach Resort).

(3) After unit owners or lot owners other than the Developer are entitled to elect a majority of the members of the Board of Directors, directors of the Association shall be elected at an annual meeting of the members in the manner determined by the By-Laws. Directors may be removed and vacancies on the Board of Directors shall be filled in the manner provided by the By-Laws."

ARTICLE VII

OFFICERS. The affairs of the Association shall be administered by the officers designated in the By-Laws. The officers shall be elected by the Board of Directors at its first meeting following the annual meeting of the members of the Association and shall serve at the pleasure of the Board of Directors The names and addresses of the officers who shall until serve their successors are designated by the Board of Directors are as follows:

ARTICLE VIII

INDEMNIFICATION. Every director and every officer of the Association shall be indemnified by the Association against all expenses and liabilities, including attorney's fees, reasonably incurred by or imposed upon him in connection with any proceeding

or any settlement of any proceeding to which he may be a party or in which he may become involved by reason of his being or having been a director or officer of the Association, whether or not he is a director or officer at the time such expenses are incurred, except when the director or officer is adjudged guilty of willful misteasance in the performance of his duties. The foregoing right of indemnification shall be in addition to and not exclusive of all of the rights to which such director or offices may be entitled. The directors shall be authorized to purchase directors and officers liability insurance providing coverage to the officers and directors of the Association.

ARTICLE IX

BY-LAWS. The first By-Laws of the Association shall be adopted by the Board of Directors and may be altered, amended or rescinded in the manner provided by the By-Laws.

ARTICLE X

AMENDMENTS. Amendments to the Articles of Incorporation shall be proposed and adopted in the following manner:

- (A) Notice of the subject matter of a proposed amendment shall be included in the notice of any meeting at which a proposed amendment is considered.
- (B) A resolution for the adoption of a proposed amendment may be proposed either by the Board of Directors or by the members of the Association. Directors and members not present in person or by proxy at the meeting considering the amendment may express their approval in writing provided such approval is delivered to the secretary or assistant secretary at or prior to the meeting. Except as elsewhere provided, such approvals must be by not less than two-thirds (2/3) of the vote of the entire membership of the Association,
- (C) Provided, however, that no amendment shall make any changes in the qualifications for membership nor the voting rights of members without approval in writing by all members and the

joinder of all record owners of mortgages upon any unit in a condominium or lot in a subdivision operated by the Association.

- (D) provided, further, that no amendment shall abridge, limit or alter the rights reserved by or granted to the Peveloper, its successors or assigns, or any successor developer, by these Articles or By-Laws without the prior written consent of the Developer, its successors or assigns, or a successor developer.
- (E) A copy of each amendment shall be certified by the Secretary of State and recorded in the public records of Walton County, Florida.

ARTICLE XI

TERM. The term of the Association shall be perpetual.

DISPOSITION OF ASSETS UPON DISSOLUTION. Upon dissolution of the Association, the assets, both real and personal of the Association, shall be dedicated to an appropriate public agency or utility to be devoted to purposes as nearly as practicable the same as those to which they were required to be devoted by the Association. In the event that such dedication is refused, such assets shall be granted, conveyed and assigned to any non-profit corporation, association, trust or other organization to be devoted to purposes as nearly as practicable the same as those to which they were required to be devoted by the Association.

No disposition of Turtle Beach Resort Community Association, Inc. properties shall be effective to divest or liminish any right or title of any member vested in him under the resorded declaration of condominium for any condominium or the recorded declaration of covenants and restrictions of any subdivision operated by the Association, unless made in accordance with the provisions of any applicable declaration.
