**ARTICLES OF AMENDMENT  
TO  
ARTICLES OF INCORPORATION  
OF  
JEWISH INSTITUTE FOR THE ARTS, INC.  
(A Not For Profit Corporation)**

The articles of incorporation of Jewish Institute For The Arts, Inc., document number N9600000 3862, were amended by the corporation's board of directors on January 5<sup>th</sup>, 1998, pursuant to the Florida Not For Profit Corporation Act, §617.1001.

1. The name of the corporation is Jewish Institute For The Arts, Inc.
2. The articles of incorporation are amended by changing Article III, Powers, to read:

**POWERS**

The Corporation shall have the power to acquire, own, maintain and use its assets for the purposes for which it is organized, to raise funds by any legal means for the encouragement of its purposes; to acquire, hold, own, use, and dispose of real or personal property in connection with the purposes of the Corporation; to exercise all powers necessary or convenient to the furtherance of the purposes for which the Corporation is organized.

3. The articles of incorporation are further amended by changing Article IV, Limitations, Paragraph B, to read:

**LIMITATIONS**

B. No substantial part of the activities of the Corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

4. The foregoing amendment to the articles of incorporation was adopted unanimously by the board of directors on January 5<sup>th</sup>, 1998. There are no members of the corporation and no members entitled to vote on the amendment.
