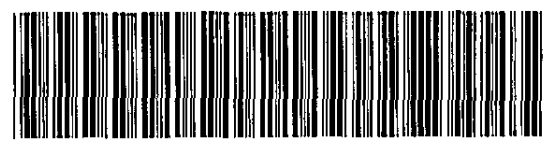

We are in receipt of your letter dated October 28, 2005 regarding the above-captioned corporation, a copy of which is enclosed.


Enclosed please find the revised Articles of Amendment for filing which addresses the issues contained in said letter.

ARTICLES OF AMENDMENT

OF

ABIDING FAITH CHRISTIAN MINISTRIES, INC.

WHEREAS, ABIDING FAITH CHRISTIAN MINISTRIES, INC. is a duly organized not for profit corporation existing under the laws of the State of Florida, and

WHEREAS, the Board of Trustees and Members of ABIDING FAITH CHRISTIAN MINISTRIES, INC. by resolution unanimously adopted on the 11th day of July, 2002, have resolved to make certain changes in the Articles of Incorporation and hereby show and manifest our intention that the Articles of Incorporation be altered and amended by deleting Article I therefrom and substituting in lieu thereof the following provision:

ARTICLE I

Name

The name of this corporation is **ABIDING FAITH CHRISTIAN MINISTRY, INCORPORATED.**

WHEREAS, the Board of Trustees and Members of ABIDING FAITH CHRISTIAN MINISTRIES, INC. by resolution unanimously adopted on the 11th day of July, 2002, have resolved to make further changes in the Articles of Incorporation and hereby show and manifest our intention that the Articles of Incorporation be further altered and amended by deleting Article II therefrom and substituting in lieu thereof the following provision:

ARTICLE II

PURPOSES

A. The purpose of this corporation shall be to establish and maintain a church and to provide a place of public worship and prayer in the City of Gainesville, County of Alachua, State of Florida; to establish, maintain and conduct a school for religious instruction of children and adults; to buy, sell, lease, mortgage or otherwise encumber, hold or dispose of both real and personal property of the corporation; to further all religious and charitable work; and for such purpose to

adopt and establish by-laws, rules and regulations in accordance with law and not inconsistent with these Articles of Incorporation.

B. This corporation shall not, as a substantial part of its activities, carry on propaganda or otherwise attempt to influence legislation; nor shall it participate or intervene (by publication or distribution of any statements or otherwise) in any political campaign on behalf of any candidate for public office.

WHEREAS, the Board of Trustees and Members of ABIDING FAITH CHRISTIAN MINISTRIES, INC. by resolution unanimously adopted on the 11th day of July, 2002, have resolved to make further changes in the Articles of Incorporation and hereby show and manifest our intention that the Articles of Incorporation be further altered and amended by deleting Article XI therefrom and substituting in lieu thereof the following provision:

ARTICLE XI

DISPOSITION UPON DISSOLUTION

On the dissolution or winding up of this corporation, or in the event it shall cease to carry out the objects and purposes herein set forth, all the property and assets of the corporation remaining after the board of trustees has paid or made provisions for the payment of all of the debts and liabilities of the corporation shall be distributed to such nonprofit, tax exempt under Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding section of any federal tax code then in effect, fund(s), foundation(s) or corporation(s) that is or are organized and operated exclusively for religious, charitable, educational or scientific purposes as may be selected by the board of trustees of this corporation so that the properties and assets of this corporation shall then be used for, and devoted to, the purposes of carrying on the religious objects and work of this corporation. If the property and assets of this corporation are distributed on dissolution by a court of competent jurisdiction and not by the trustees, such court is requested to make such distribution of the remaining property and assets of this corporation to a similar religious fund, foundation or corporation then in existence and eligible to receive such distribution as may be best determined by such court to be so organized and directed as to carry forward the religious objects and works of this corporation.
