The undersigned acting as incorporators of a corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE I

The name of the corporation shall be **PORT ST. LUCIE POLICE ATHLETIC LEAGUE, INC.**

ARTICLE II

The principal place of business and mailing address is at The Port St. Lucie Police Department, 121 S.W. Post St. Lucie Blvd., Port St. Lucie, FL 34984.

ARTICLE III

The purposes for which this not-for-profit corporation is organized, is to help develop and facilitate a relationship between individual children and law enforcement officers for the purpose of enhancing their problem solving skills, emotional and education potential, psychological preparedness, social adjustment, and self esteem, through sporting activities including boxing, street hockey, basketball and archery. Additionally, this corporation is being organized to help students at risk of dropping out of high school through the P.A.L "at risk" program, which targets such students and helps encourage them to stay in school.

ARTICLE IV

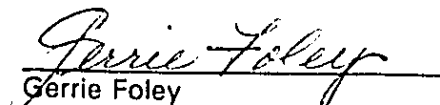
