To Whom it May Concern:

My name is Mona-Eileen Byrnes. I am the Treasurer of the above-named corporation. Our Board of Directors held their business meeting on September 22, 2000 at 7:00 pm. At this meeting we were given the enclosed URB which states it was a second notice and that the deadline for filing was September 13th. This board was never given the 1st notice and have no idea where it was delivered or who, if anyone, might now have it in their possession.

EXPLANATION OF LATE FILING:

We are a small community of seventy-three homes, one is vacant having been foredosed upon; and others are in the same process. Our annual association dues originally were Seventy-Five (\$75.00) Dollars per household per year. The dues were raised to One Hundred Twenty-Five (\$125.00) Dollars per household per year for the year 2000. Several households have not paid their 2000 association dues and proper action is commencing in that regard.

Prior to the inception of this Board of Directors last month, a former board had held office. It is sad for us to relate that the former board did not act decisively. It soon became apparent that several board members were ill equipped to handle their responsibilities and even less cognizant of what their responsibilities were. During their tenure some erroneous interpretations of our rules and regulations as to real estate and bylaws of the Association resulted in many hard feelings and eroded what little unity there was in our community to begin with.

It soon became apparent that some drastic action had to be taken. Several of our homeowners refused to pay their association dues. Several liens were filed and we have other properties in foreclosure proceedings. We quickly scheduled a meeting. Homeowners were entirely disenchanted with the former board. We had a most difficult time procuring a quorum for the meeting; however, we finally succeeded. At this meeting five dedicated and - -shall we say? – brave individuals volunteered as board members. Their names and addresses are listed on the enclosed form.

At our meeting on September 22, 2000, we were given this 2000 URB. In perusing the form we noted that the principal place of business listed is entirely unknown to us. We have no idea how the form finally reached our hands. It appears that someone had originally filed the corporation papers, because the original board members' names and addresses are properly listed.

All members of the board were upset to discover that the URB should have been filed before September 13th. Also enclosed as Exhibit 1, is a copy of the E-mail I sent to your E-mail address when I returned home from our September 22 meeting. I also called your office on Friday only to learn it was closed due to the storm Helene. I then attempted to procure a form through
