#### **EXHIBIT "A"**

## AMENDMENTS TO ARTICLES OF INCORPORATION OF MEDITERRANIA HOMEOWNERS ASSOCIATION, INC.

Article 7, DIRECTORS, Section 7.1 of the Articles of Incorporation, shall be amended to read as follows:

[Added language is underlined. Deleted language is struck through.]

#### ARTICLE 7. DIRECTORS

7.1 The property, business and affairs of the ASSOCIATION shall be managed by a BOARD which, commencing with the 2005 Annual Members Meeting, shall consist of five (5) not less than three (3) directors, and which shall always be an odd number. The BYLAWS may provide for a method of determining the number of directors from time to time. In the absence of a determination as to the number of directors, the BOARD shall consist of three (3) directors. At the 2005 Annual Members Meeting, the three(3) Directors receiving the highest number of votes from the Owners shall be elected to initially serve two(2) year terms, and the remaining two(2) Directors shall be elected to initially serve one(1) year terms. If there is not a quorum to conduct the 2005 Annual Members Meeting or if there are not more candidates than openings at the 2005 Annual Members Meeting, the Board may determine which directors will initially serve two(2) year terms and initially serve one(1) year terms. After the above referenced initial terms, all Directors shall serve staggered two(2) year terms, with the terms of either three(3) or two(2) Directors expiring each year. Directors are not required to be members of the ASSOCIATION.
