ARTICLES OF INCORPORATION  
OF  
ALUMNI ASSOCIATION OF SREE NARAYANA COLLEGES IN KOLLAM, INC.  
(a corporation not for profit)

ARTICLE I

This is a nonprofit corporation organized for the purposes set for herein pursuant to and under the provisions of Chapter 617, Florida Statutes.

ARTICLE II

The name of this corporation is: Alumni Association of Sree Narayana Colleges in Kollam, Inc.

ARTICLE III

The corporation is organized and shall be operated exclusively as a nonstock charitable organization for the following purposes:

1. For the benefit of Sree Narayana Colleges in Kollam in the state of Kerala, India for physical maintenance as an educational institution of excellence.
2. For the maintenance and beautification of the campus.
3. For providing books, journals, and technical assistance as needed for improving educational qualities in the institution.
4. To provide counseling and guidance in employment opportunities in different part of the world as opportunities arise.
5. To provide counseling for qualified students and teachers in prospects of higher education and training in the United States of America.
6. To encourage and recognize those who dedicated their efforts for the improvement and welfare of the institution.
7. To act upon any other worthy and charitable cause directly benefiting the institution and the students at large.

#### ARTICLE IV

This corporation is to begin its existence upon the date and time of the filing of the Articles of Incorporation with the Department of State, and shall there after exist perpetually. The corporation shall have all powers conferred upon non-profit corporations by the law of the State of Florida.

#### ARTICLE V

Section 1. Membership of the association shall be as provided herein. Persons who are previous students of Sree Narayana Colleges of Kollam, Kerala, India who are of good moral and ethical character shall be eligible to apply for membership of the association by making application to the President or the President's designee. Membership requires nomination by the President or designee and approval by the board of directors by two-thirds majority by vote for the general membership. Members shall enjoy equal rights in the management of the affairs of the association. A board of directors elected from the members will be responsible for implementing various activities of the association as described in article three

Section 2. Other qualifications for membership of this association and the manner of their admission shall be governed and regulated by the by-laws of this association.

#### ARTICLE VI

Section 1. The business affairs of this corporation shall be managed by a board of directors. The association shall initially have five directors. The number of directors may be decreased or increased from time to time by the by-laws of the association but shall always be an odd number never less than three and never more than seven directors. The board of directors consist of

- A. the officers
- B. the immediate past President
- C. general directors

Section 2. The board of directors shall be members of the association. Members of the board of directors shall be elected and hold office in accordance with the by-laws.

Section 3. The names and addresses of the persons who are to serve as directors for the ensuing year or until the first annual meeting of the corporation are as follows:

Section 4. The officers of the association shall be as follows and the specific powers and duties shall be as set forth in the by-laws:

- (a) President
- (b) Vice President
- (c) Secretary
- (d) Treasurer

Section 5. Officers and general directors shall be elected by the membership and shall hold office continuously until fifteen days following the election of new officers or until their lawful removal. The officers shall not be eligible to hold more than two full and successive terms for the same office. The initial general directors shall hold office for (1), two (2), or three (3) year terms; and thereafter general directors shall be elected for a term of three years.

Section 6. The corporations principal office and mailing address shall be 8 Ocean Drive, Punta Gorda, Florida, 33950.

## ARTICLE VII

Section 1. The association may exercise all the powers which are now or hereafter conferred by law upon associations not organized for pecuniary gain or profit or necessary or incidental to the powers so conferred, or conducive to the attainment of the purposes of the association, subject to such limitations as are or may be prescribed by law and subject specifically to the following restrictions. Notwithstanding any other provisions of this Charter, no substantial part of the activities of the association shall be the carrying on of propaganda or otherwise attempting to influence legislations; and the association shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. The association shall not carry on any other activities not permitted to be carried on (a) by a association exempt from Federal Income Tax under section 501 (c)(3) of the Internal Revenue Code of 1954) or the corresponding provisions of any future United States Internal Revenue Law) or (b) by a association, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).

Section 2. Should the association be dissolved, by the expiration of the Charter or otherwise then all assets owned by the association shall be distributed to such associations or organizations as would then qualify for exemption from federal income tax under the provisions of Section 501 (c)(3) under the Internal Revenue Code of 1954 (or the corresponding provisions of any future United States Internal Revenue Law)

ARTICLE IX

Section 1. The Board of Directors of this incorporation may provide such by-laws for the conduct of its business in the carrying out of its purposes as they may deem necessary from time to time.

Section 2. Upon proper notice, the By-Laws may be amended, altered or rescinded by a majority vote of those members for the Board of Directors present at any regular meeting or any special meeting called for that purpose.

ARTICLE X

Section 1. The articles of incorporation may be amended at a special meeting of the membership called for that purpose by a two-thirds majority vote of those present

Section 2. Amendments may also be made at a regular meeting of the membership upon notice given, as provided by the by-laws, of intention to submit such amendments.

Section 3. No amendments may be made affecting the provisions of article VII

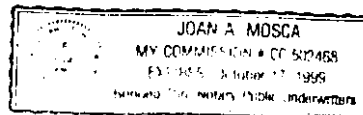


