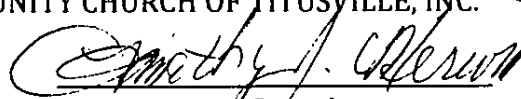
The name of the corporation is hereby changed to read as follows:

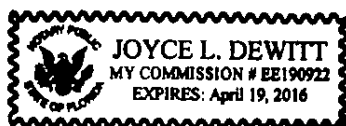

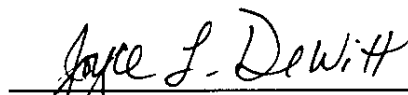
