- ONE The name and address of the principal corporation is Tyson's Community Development, Inc. 542-22nd Street, West Palm Beach, Florida 33404 Palm Beach County Florida The corporation is organized pursuant to the FLORIDA Nonprofit Corporation Code
- TWO This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person The corporation is organized under the Nonprofit Public Benefit Corporation Law for charitable and educational purposes to aid the poor and disadvantaged individuals and families towards a life of self-sufficiency The program will consist of, but shall not be limited to Job Training, Job Placement, Land Acquisition, Housing, Employment, Literacy, Counseling, Temporary Shelter Teenage Pregnancy, Tutoring, AIDS, Elderly Care, Pre-K Program, Mentor Program, Christian Book Store, Computer Program, After School Care, and other programs to aid those in need
- THREE The duration of this corporation shall be perpetual, no stock, and shall have no members
- FOUR The address of the Registered office is 542-22nd Street, West Palm Beach, Florida 33407, Palm Beach County The name of the registered agent of the corporation shall be Malissa N Tyson *Malissa N. Tyson*
- FIVE
- (a) This corporation is organized and operated exclusively for Educational and Charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.
- (b) Notwithstanding any other provisions of these Articles, the corporation shall not carry on any other activities not permitted to carry on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.
