

ARTICLES OF INCORPORATION
OF

A FLORIDA CORPORATION NOT-FOR-PROFIT

ARTICLE ONE

NAME

The name of the Corporation is LOVE AND MIRACLES OF JESUS CHRIST CORPORATION.

ARTICLE TWO

DURATION

The term or existence of the Corporation is perpetual; and the corporation existence will commence on August 30th, 1996.

ARTICLE THREE

PURPOSE

1. To regularly assemble together the members of this church for the fellowship one with another and to worship the one true God.
2. To aid in the spreading of the Gospel of Jesus Christ.
3. To provide study and teaching of the Holy Bible and to distribute the Holy Bible and other Sacred literature.
4. To promote and manifest the life and principles of the Kingdom of God, in accordance with the Holy Bible.
5. To baptize in water; to anoint, the sick with oil; to marry; to dedicate infants; to celebrate the Lord's Supper; and to bury.

8. To receive and dispense funds in accordance with the instructions of the Holy Bible and pursuant to the Statutes of the State of Florida for non-profit corporations.

9. To establish, structure and oversee Christian Fellowships within society which will provide for all of the basic needs of each Christian to mature in Christ and do His will.

10. To ordain ministers and to send forth missionaries for the upbuilding of other churches.



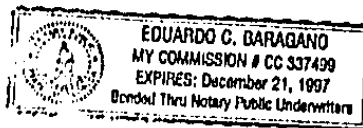
