The undersigned, acting as Founder and Incorporator of a Corporation pursuant to chapter 617, of the Florida Statutes, adopt the following Articles of Incorporation for such Corporation on July 03, 1996, in Miramar, Broward County, Florida.

**Article I**

The name of this Church shall be " JESUS IS THE ANSWER MINISTRIES, INC."

**Article II**

This Church is located at 3280 S. University Dr. Miramar, Fla. 33025 and the mailing address is : 9816 N.W. 5th Court, Plantation, Fla. 33324

**Article III**

The purposes for which the Corporation is organized are :

- 1- To preach and teach the Gospel of our Lord Jesus Christ according to the interpretation given in the By-Laws of this Corporation .
- 2- To incorporate other churches to our Corporation, included but not limited to missions.
- 3- To Ordain Ministers.

**Article IV**

The duration the congregation is to continue shall be perpetual unless dissolved only by the President.

**Article V**

The Registered Agent for the Corporation will always be : Rev. Thomas A Friday, living at 9816 N.W. 5th Court. Plantation, Fla, 33324.

**Article VI**

This Corporation is organized under a non-stock basis.

**Article VII**

The manner in which the Directors of this Corporation are to be appointed and elected, shall be defined in the By-Laws of this Corporation.

### Article VIII

The qualifications for members, its rights, requirements, responsibilities and other pertinent matters shall be defined in the By-Laws of this Corporation.

### Article IX

### Article X

This Corporation will be directed and administered by the Pastor of the Church whom shall also be the President of the Corporation.

The Pastor will designate a Ministerial Body to assist him with the spiritual aspect of the Church. Such Body will consist of :

- 1- The Elders
- 2- The Deacons
- 3- The Ministries

### Article XI

In the event of dissolution, the residual assets of the Organization will be turned over to one or more Organizations which themselves are exempt as Organizations described in Sec. 501-C-3 and 170-C-2 of the Internal Revenue Code of 1954 or corresponding Sections of any prior or future law, or to the Federal, State or Local government for exclusive public purpose.



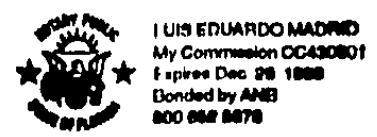


