

No substantial part of the activities of this corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation. This corporation shall not participate or intervene in any political campaign on behalf of any candidate for public office, including the publishing or distribution of statements. Notwithstanding any other provision of these articles, this corporation shall not carry on ant other activities not permitted to be carried on by a corporation exempt from federal income tax under § 501 (c)(3) of the Internal revenue Code of 1954 or the corresponding provision

of any future United States Internal Revenue Law, or by a Corporation contributions to which are deductible under § 170 (c)(2) of the Internal revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue Law. On the dissolution of this corporation the Board of Directors shall dispose of all of the assets of this Corporation exclusively for the purposes of this Corporation in the manner or to the organization or organizations that are organized and operated exclusively for charitable, educational, religious, or scientific purposes and that shall at the time qualify as exempt organizations under § 501 (c)(3) of the Internal revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue Law, after paying or making provisions for the payment of all liabilities of this corporation.
