AMENDMENT TO

ARTICLES OF INCORPORATION

AMENDMENTS

ARTICLE I NAME

The name of the corporation shall be <u>LAKEVIEW HOMEOWNERS ASSOCIATION</u>, <u>INC.</u>, <u>LAKEVIEW ESTATES HOMEOWNERS' ASSOCIATION</u>, <u>INC.</u>, hereinafter referred to as the "Association" or "Corporation".

ARTICLE VII

The initial street address of this corporation is 4398 N. W. 25th Way, Boca Raten, Florida 33434 6800 Windpoint Way, Lake Worth, FL 33467. The initial mailing address is the same.

ARTICLE VIII DIRECTORS

Section 2. Directors shall be elected by the voting members in accordance with the By-Laws at regular annual meetings of the membership of the Association, in the manner set forth in the By-Laws. At the said meeting, two (2) members of the Board of Directors shall be elected for a term of one (1) year. In the event of a vacancy, the remaining director(s) shall appoint a replacement to serve the balance of the term: a two (2) year term and three (3) for a one (1) year term. The length of term for which a nominee is elected at the January 2005 annual meeting shall be determined by the number of votes each nominee receives. The two (2) nominees receiving the most votes shall serve the two (2) year terms, and the next three (3) highest shall serve one (1) year terms. At each annual meeting thereafter a number of Directors could to that of those whose terms

have expired shall be elected for a term of two (2) years. At the expiration of any term of two (2) years, any Director may be re-elected.

In all other respects, the Articles of Incorporation shall remain as they were prior to this Amendment being adopted.
