Articles of Incorporation

SOOT IN PULL TO The undersigned incorporator(s), for the purpose of forming a not for profit corporation under the Florida Business Corporation Act, hereby adopt(s) the following Articles of Incorporation.

Article I

The name of the not for profit corporation shall be: Vero Lake Estates Property Owners, Inc.
