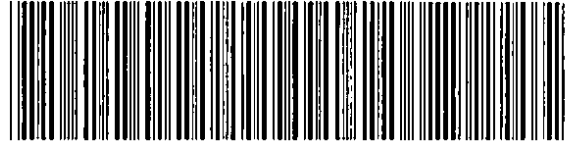

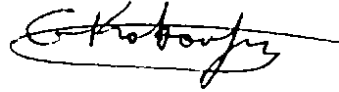

**OPENING OF INVESTMENT ACCOUNT**

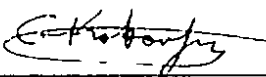
