These Articles of Amendment to the Articles of Incorporation of We Care Jacksonville, Inc., a Florida not-for-profit corporation (the "Corporation"), are adopted and filed pursuant to the provisions of the Corporation's Articles of Incorporation, Bylaws, and Sections 617.1001, 617.1002(b) and 617.1006, Florida Statutes, having been duly authorized, approved and adopted by unanimous vote of the of the Board of Directors, who are also the Members of the Corporation, at a meeting properly noticed and held on June 27, 2002.

1. The name of this Corporation is WE CARE JACKSONVILLE, INC.
2. Article III, Section 3.1, of the Articles of Incorporation of WE CARE JACKSONVILLE, INC. is hereby amended to read as follows:

ARTICLE III

PURPOSE, LIMITATIONS AND DISSOLUTION

Section 3.1 Purposes. The Corporation is organized and shall be operated exclusively for charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, and the Treasury Regulations issued thereunder, or the corresponding provisions of any future United States Revenue Law (the "Code"), and its primary purpose is to facilitate the provision of health care services through a network of volunteer health care professionals.

3. The above referred to amendment shall become effective and upon filing with the Florida Department of State, and the Articles of Incorporations of WE CARE JACKSONVILLE, INC. shall be deemed to be amended accordingly.

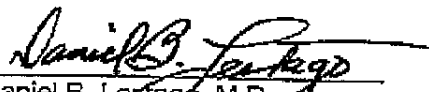
