## ARTICLES OF AMENDMENT

The following provisions of the Articles of Incorporation of MYSTIC PLACE CONDOMINIUM ASSOCIATION, INC., a Florida corporation, filed in Tallahassee, Florida on October 30, 1996 be and they are hereby amended in the following particulars:

Article IX Section 9.6 be and it hereby is amended to read as follows:

- "9.6 Unit Owners Election of Directors. Within seventy-five (75) days after the Unit Owners, other than the Developer, are entitled to elect a member of the Board of Directors of the Association, the Association shall call, and give not less than sixty (60) days' notice, an election for the members of the Board of Directors. The election shall proceed as provided in Florida Statutes Chapter 718.112(2)(d). The notice may be given by any Unit Owner if the Association fails to do so. Upon election of the first Unit Owner, other than the Developer, to the Board of Directors, the Developer shall forward to the Division of Florida Land Sales, Condominiums and Mobile Homes the name and mailing addresses of the unit Owner Board Member.
- The foregoing amendment was adopted by the Directors of the corporation on the 14<sup>th</sup> day of January, 1997. Pursuant to Article XII of the Articles of Incorporation, the foregoing amendment was adopted by the Directors only, there being no members of the corporation.
