The undersigned hereby files these Articles for the purpose of becoming a corporation under the laws of the State of Florida, by and under the provisions of the Statutes of the State of Florida, providing for the formation, liability, privileges and immunities of a corporation not for profit.

# ARTICLET

## NAME

The name of this corporation shall be:

AAA Business Park of New Smyrna Beach Owners' Association, Inc.

## ARTICLE II

# **DURATION**

This corporation shall exist perpetually unless sooner terminated in accordance with law.

# ARTICLE III

### **PURPOSE**

This corporation is organized for the purpose of providing an entity under the Laws of the State of Florida for the operation of an owners' association located in Volusia County, Florida, and known as AAA Business Park of New Smyrna Beach Owners' Association, Inc., created

Exercise all of the powers and privileges and to perform all the duties and obligations of the Association as set forth in that certain Declaration of Covenants and Restrictions applicable to the Property and recorded in the Public Records of Volusia County, Florida.

Fix, levy, collect and enforce payment by any lawful means, all charges or assessments pursuant to the terms of the Declaration and the Bylaws; pay all expenses a connection therewith and all the office and other expenses incident to the conduct of the business of the Association.
