ARTICLES OF AMENDMENT

1. The following provisions of the Articles of Incorporation of GREATER ROTONDA ORGANIZATION, INC., a Florida not for profit corporation, filed in Tallahassee on November 15, 1996, be and they hereby are amended in the following particulars:

Article 9, Section 1., be and it hereby is amended to read as follows:

"The business affairs of this corporation shall be managed by the Board of Directors. This corporation shall have three directors initially. The number of directors may be increased or decreased from time to time by the Bylaws, but shall never be less than five or more than thirty." See attached Exhibit A for additional directors.
