ARTICLES OF INCORPORATION

The undersigned, acting as incorporator(s) of a corporation pursuant to chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:

ARTICLE I NAME

Purposes

The specific purpose(s) for which the corporation is organized is (are):

for charitable and educational purposes as will qualify it as an exempt organization under SECTION 501(c)(3) of the Internal Revenue Code of 1954 or corresponding provisions of any subsequent federal tax laws including, for such purposes, the making of distributions to organizations which qualify as tax-exempt organizations under that code. Within the scope of the foregoing, the corporation is specifically organized to:

- a) maintain and operate a rescue service for Dalmatians,
- b) care for the dogs through all necessary means including operations, vaccinations, medication, etc.
- c) place these Dalmatians in good, caring, loving homes
- d) to improve community awareness of the need to care for Dalmatians
- e) do all things necessary to accomplish the purposes for which it is organized and chartered, including raising money for any purposes of the Corporation from time to time without limit as to amount.
- f) exercise any specific or general powers granted the Corporation pursuant to the Florida Statutes Chapter 617 (1981).
