#### ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

#### ARTICLE I

The name of the Corporation shall be:

College and University Personnel Association, Florida Chapter, Inc.

The principal place of business and the mailing address of the Corporation shall be:

### ARTICLE III

The specific purposes for which the Corporation is organized are to:

- (1) provide opportunities for professional development and the exchange of human resources/personnel knowledge and experiences among human resources practitioners from all the diverse higher education institutions in Florida;
- (2) provide leadership to improve the standards of performance in all aspects of human resources/personnel administration in Florida higher education;
- (3) encourage adherence to professional standards of ethical behavior in human resources/personnel operations and activities in Florida higher education; and
- (4) supplement and support the mission and focus of both the National CUPA and Southern Region CUPA organizations.

### ARTICLE IV Manner of election of directors

Voting rights in the Corporation are limited to the Directors of the Corporation. The manner in which the directors are elected or appointed is as follows:

Directors of the Corporation shall be designated annually in accordance with the election of officers by the membership of the Chapter organization. Directors are the Chair, Chair-Elect, Secretary, and Treasurer of the organization.

The persons elected annually as Chair-Elect, Secretary, and Treasurer of the organization shall become Directors of the Corporation on the first day of July immediately following their election and remain as Directors for one year or until resignation or lawful termination of term by the organization. The Chair-Elect assumes the office of Chair of the organization on July 1 immediately following completic of service through June 30 as Chair-Elect and is designated as a Director of the corporation for the duration of the term as Chair of the organization.

The Chair for the year beginning in July following the due date of the corporation's Annual Report shall be designated as the Registered Agent in the Annual Report.

## ARTICLE V Limitation of corporate powers

The activities of the corporation will be conducted in accordance with the Constitution of the organization and any lawful amendments. The Constitution of the organization serves as the bylaws of the corporation. The Constitution may be amended by the organization's membership and shall serve as the only method of amending the Corporation's bylaws.

No compensation shall accrue to Directors for their service.
