The undersigned, the President of Barry Telecommunications, Inc., a not for profit corporation organized and existing under the Florida Not For Profit Corporation Act (the "Corporation"), in accordance with the provisions of Sections 617.01201 and 617.1006 thereof, does hereby certify:

FIRST: The name of the corporation is Barry Telecommunications, Inc.

SECOND: The Corporation's articles of incorporation have been amended by deleting Article II, Section 1 and substituting in its place the following:

Section 1. The general purpose of this Corporation is to be an educational or non-commercial broadcasting entity within the meaning of that certain agreement made the 10th day of February 1989 between the Board of Education of the State of Florida and South Florida Public Telecommunications, Inc., to operate public education telecommunication stations and provide community service and presence within a more caring environment, and to carry on any other purpose that is allowed under the Florida Not For Profit Corporation Act.

THIRD: The amendment to the Corporation's articles of incorporation was adopted by a unanimous written consent of the sole voting member dated as of February 18, 1997, and such action was sufficient for approval of the amendment pursuant to Florida Statutes Section 617.1002(2).
