ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF CHAPLIN FAMILY FOUNDATION, INC.

Pursuant to the provisions of section 617.1006, Florida Statute, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

The undersigned, a Member of the CHAPLIN FAMILY FOUNDATION, INC., a Florida Not For Profit Corporation, does hereby manifest his intention that ARTICLE V and ARTICLE VIII of the Articles of Incorporation of the CHAPLIN FAMILY FOUNDATION, INC., originally filed in the office of the Secretary of State of Florida on February 6, 1997, be amended effective immediately upon the filing of this Amendment, so that ARTICLE V and ARTICLE VIII of the Articles of Incorporation shall now read and provide as follows:

FIRST: ARTICLE V - QUALIFICATION OF MEMBERS AND THE MANNER OF THEIR ADMISSION

The Foundation shall have a membership distinct from the Board of Trustees. The number of Members of the Foundation shall be provided for in the Bylaws of the Foundation.

Only the Trustees of the Foundation shall qualify as Members of the Foundation. The manner in which a Member shall be admitted to the Foundation shall be set forth in the Bylaws.

SECOND: ARTICLE VIII - MANAGEMENT OF CORPORATE AFFAIRS.

(a) <u>Board of Trustees</u>. The powers of this Foundation shall be exercised, its properties controlled and its affairs conducted by a Board of Trustees. The number of Trustees of the Foundation and the manner in which they are elected or appointed shall be set forth in the Bylaws duly adopted by

the Members of the Foundation.

THIRD: The date of adoption of the amendment was: April 2, 2000.

FOURTH: The Amendment was adopted by the Members and the number of votes cast for

the amendment was sufficient for approval.
