## FIRST AMENDMENT TO THE ARTICLES OF INCORPORATION OF OKECHEELEE JUNIOR GOLF FOUNDATION, INC.

Pursuant to Section 617.1006, Florida Statutes, the undersigned officer, being duly authorized, empowered and directed to act, hereby files this First Amendment to the Articles of Incorporation of OKEEHEELEE JUNIOR GOLF FOUNDATION, INC., a Florida not-for-profit corporation (the "Corporation") and hereby certifies the following:

- 1. The name of the Corporation is OKEEHEELEE JUNIOR GOLF FOUNDATION, INC.
- 2. The original Articles of Incorporation of the Corporation were filed with the Florida, Department of State on April 17, 1997.
- 3. Article I of the original Articles of Incorporation shall be and hereby is amended by replacing Article I in its entirety to read as follows:

## **ARTICLE I**
