ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION

Pursuant to the provision of Chapter 617, Florida Statutes, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation.

1. The name of the corporation is:
RUSKIN CHURCH OF CHRIST, INC.

2. The following amendments to the Articles of Incorporation were adopted by the corporation:

An addition is made to Article Two (II) of the Articles of Incorporation, by the addition of the following paragraph:

" Notwithstanding any other provisions of these Articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income Tax under section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law."

3. This amendment was adopted by the Board of Directors and trustees on 30 December, 1997, in accordance with the procedure for amendment of the Articles of Incorporation as set forth in the Articles of Incorporation.

4. The above amendments were approved by a majority of the

members of the directors and trustees of the Corporation.

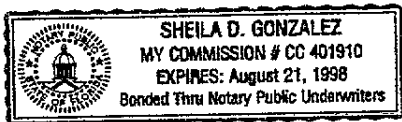
