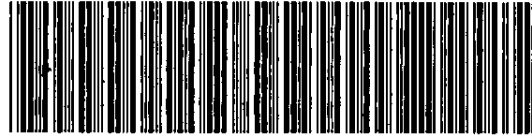

**ARTICLE III, paragraph A.**

This organization is organized exclusively for charitable, religious, educational and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. Furthermore, this organization may engage in only activities permitted under the laws of the State of Florida and Internal Revenue Service, as shall constitute activities in furtherance of such exempt purposes. In furtherance of its exempt purposes the organization may promote, establish, conduct and maintain activities on its own behalf and may contribute to or otherwise assist other organizations and institutions carrying on exempt activities.

**Article III, paragraph F.**

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future tax code, or shall be distributed to the federal government, for a public purpose. Any such assets not disposed of shall be not disposed of shall be disposed of by a court of competent jurisdiction in the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.
