

**ARTICLES OF AMENDMENT TO THE  
ARTICLES OF INCORPORATION OF**

**DOT RICHARDSON SOFTBALL ASSOCIATION, INC.**

Pursuant to the provisions of Section 617.1006 of the Florida Statutes, Dot Richardson Softball Association, Inc., a nonprofit corporation, adopts the following Articles of Amendment to its Articles of Incorporation:

1. The current name of the corporation is DOT RICHARDSON SOFTBALL ASSOCIATION, INC.
2. The original Articles of Incorporation for the corporation were filed on September 8, 1997.
3. By written consent executed on MARCH 4, 2002 by all of the members of the Board of Directors of the Corporation pursuant to Section 617.0821 of the Florida Statutes, the Directors have agreed that the Articles of Incorporation of the corporation be amended as stated below. The Corporation has no members.
4. Article I of the Articles of Incorporation of the Corporation is hereby amended to read as follows:


"ARTICLE I - NAME OF CORPORATION"
