To Whom It May Concern:

Yesterday we were surprised to learn that Downtown Vision, Inc.'s corporation status has been revoked due to a failure to file our Annual Uniform Business Report.

Downtown Vision, Inc. originally filed the 2001 Uniform Business Report on April 16, 2001. When we received the notice of dissolution on October 15, 2001, we called the Division of Corporations and were informed that our original application was rejected due to a lack of Directors. We were also informed that a rejection notice was mailed in late April, and followed up by another in late August. Neither notice was received by our organization.

According to your office, the first letter was mailed to 214 N. Hogan Street, Suite 120, an address we were scheduled to move into on May 1st. However, due to delays in office renovations, we did not officially move to that address until the first of June.

In late August, the second letter was sent. We received a second copy of the Uniform Business Report to complete at the end of August, but no letter of rejection or explanation accompanied the form. Upon receipt of the second form, we called the Division of Corporations to check Downtown Vision, Inc.'s status and were informed that it was active.

Our check for \$70.00 that was mailed with the original application cleared our account on April 27, 2001 and no refund check has been received.

Please find the attached copies of the original application and check, as well as a copy of the reinstatement form. As we never received the notices of rejection, or a reimbursement for the original application, we feel that Downtown Vision, Inc.'s corporation status should be restored to active, and that we should not have to pay the reinstatement fee.
