**ARTICLES OF AMENDMENT TO  
ARTICLES OF INCORPORATION OF

Pursuant to the provisions of Section 617.1006, Florida Statutes, the undersigned Florida not-for-profit corporation adopts the following Articles of Amendments to its Articles of Incorporation:

**FIRST:** Article I of the Articles of Incorporation is amended in its entirety, as follows:

The name of this corporation is **Sunscape Condominium Association, Inc.** with the principal place of business 1639 E. Cape Coral Parkway, Suite 103, Cape Coral, Florida 33904.

Article II of the Articles of Incorporation is amended to read as follows:

The purpose for which this corporation is organized is to act as the governing association of the proposed Sunscape Condominiums, located in Cape Coral, Florida.

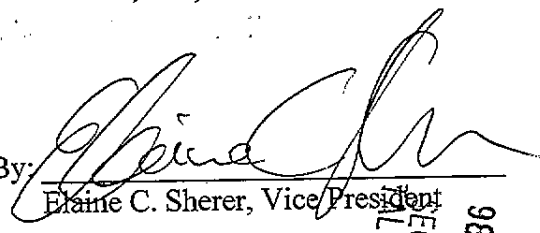
**SECOND:** The date of adoption of the amendment was March 4, 1998.
