ARTICLES OF INCORPORATION

ARTICLE I NAME

The name of the corporation shall be:

CYPRESS PRESBYTERIAN PRE-SCHOOL, INC.

The specific purpose for which the corporation is organized is

ARTICLE IV MANNER OF ELECTION OF DIRECTORS

By vote and designation of the Session of Cypress Presbyterian Church

ARTICLE V INITIAL REGISTERED AGENT AND STREET ADDRESS

ARTICLE VI INCORPORATOR

ARTICLE VII

Cypress Presbyterian Pre-School is organized exclusively for charitable, educational, religious purposes, within the meaning of section 501 (c)(3) of the Internal Revenue Code (or corresponding section of any future Federal tax code.)

ARTICLE VIII

No part of the net earning of the corporation shall inure to the benefit of, or be distributable to its members, trustees, directors, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of Section 501 (c)(3) purposes. No substantial part of

the the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in , or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

ARTICLE IX

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities nor permitted to be carried on (a) by a corporation exempt from Federal income tax under Section 501 (c)(3) of the Internal Revenue Code (or corresponding section of any future federal tax c ode) or (b) by a corporation contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code (or corresponding section of any future Federal tax code.)

ARTICLE X

Upon dissolution of this corporation assets shall be distributed for one of more exempt purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code, i.e. charitable, educational, religious corresponding section of any future federal tax code, or shall be distributed to the Federal government, or to a state or local government for a public purpose.

ARTICLE XI

However if the name recipient is not then in existence or no longer a qualified distributee, or unwilling or unable to accept the distribution, then the assets of this corporation shall be distributed to a fund, foundation or corporation organized and operated exclusively for the purposes specified in Section 501 (c)(3) of the Internal Revenue | fode (or corresponding section of any future Federal tax code.)
