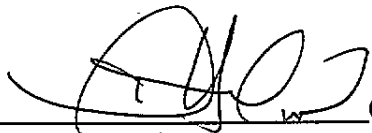

NOT FOR PROFIT ACTIVITIES AND DISSOLUTION

- A. - C. Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c)(3) of the Internal Revenue Code of 1986, or corresponding section of any future Federal tax code, or shall be distributed to the Federal, state, or local government for public purpose. Any such assets not so disposed shall be disposed by a court of competent jurisdiction of the country in which the principal office of the organization is then located, exclusively for such purposes.

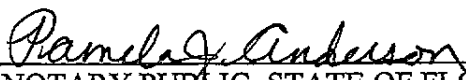

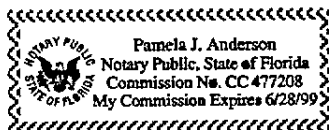

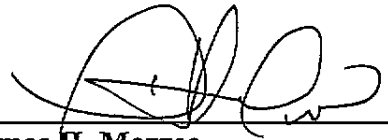
