ARTICLES OF INCORPORATION OF

GAYATRI MISSION USA, INC.

(A CORPORATION NOT FOR PROFIT)

The undersigned, acting as incorporator for the purpose of becoming incorporated under the state of Florida Not for Profit Corporation Statute, adopts the following Articles of Incorporation for said corporation.

ARTICLE I - NAME

The name of this corporation shall be as follows:

Gayatri Mission USA, Inc.

ARTICLE II - OBJECT

1. To establish a universal brotherhood among all mankind.
 2. To serve the Indian-origin community in particular by way of organizing various religious sacraments and ceremonies in general.
 3. To act as a branch of activities for the Swami Pragyanand of Vishwa Mata Gayatri Trust of Saket, New Delhi in India, who has been inspiring the community since 1980.
- His mission is to promote world peace and world brotherhood by asking people to chant the Gayatri Mantra regularly. The Gayatri Mantra is as follows:

“Om Bhur bhuvah swah, tatsavitur varenyam bhargo devasya dhimahi dhiyo yo nah prachodayat.”

In English, this translates to: “O God, Thou art the Giver of Life, the Remover of pains and sorrows, the Bestower of happiness. O Creator of the Universe, may we

4. To organize cultural activities for the community.
5. To invite visiting respected and learned religious and cultural workers and speakers from all around the world for the benefit of the community.
6. To help create awareness for the youth and women of the Indian community and aid in raising their self-esteem and moral values based on ancient Indian teachings.
7. To promote work of Hindu religion in particular.
8. In the furtherance of such objectives to purchase, sell, exchange, mortgage, rent, lease, build, own, and control real, personal, and mixed property of all kinds and nature wherever situated and however procured or received, directly or indirectly for its own use, to exercise all powers and authority conferred by law and to do all things and perform all acts necessary and incident to the furtherance of such purposes.
9. To assist sick persons like terminally ill and in unbearable pain, with the spiritual message and knowledge of the soul to make the suffering bearable.
10. To teach people deeper religious wisdom in order to keep a fine balance with materialism and spiritualism so that life can be more meaningful and fulfilling.

ARTICLE III - TERM

The term for which this corporation shall exist shall be perpetual; unless dissolved by the law.

ARTICLE IV - PRINCIPAL OFFICE

The initial post office address of the principal office of this corporation is:

The Executive Board may from time to time move the principal office to any other address.

ARTICLE V - MEMBERSHIP

All persons in sympathy with the objects of this corporation can belong to this organization. They will have the power of voting and representation.

ARTICLE VI - OFFICERS

1. The officers of this corporation shall be a President, Vice President, Secretary, and Treasurer.
2. All officers will be elected by a majority vote of the present members.
3. General body can also decide to appoint additional officers if needed.
4. The term for each officer will be three years.
5. Any officer can be removed by a two thirds of the majority vote if his/her performance has been questionable.
6. Upon the death, removal and resignation, the general membership can elect a replacement of the concerned officer for the remaining term of the concerned officer.

ARTICLE VII - FOUNDING OFFICERS

ARTICLE VIII - DISSOLUTION

In the event of dissolution, the residual asset of the organization will be turned over to one or more organizations who have a non-profit corporation under IRS Sec. 501(c).

ARTICLE IX - MEETINGS

1. Any business meeting of the corporation shall be held each year and the general body of members will be informed two weeks in advance.
2. General meetings of the members may be held any time upon call of the President or any officer in absence of the President to deal with a particular matter.

ARTICLE X - BYLAWS

The bylaws of the corporation shall be made, adopted, altered, amended, or rescinded by a two-thirds vote of the members present at a specially called for business meeting of the members.

ARTICLE XI - INDEBTEDNESS

The highest amount of indebtedness or liability to which the corporation may be at any time subject itself, which the sum shall never exceed two-thirds of the value of the property owned by the corporation.

ARTICLE XII - LIABILITY

The private property of the members of this corporation shall not be liable for the debts of this corporation.

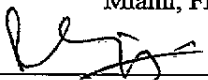

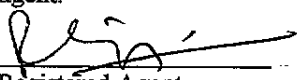
