ARTICLES OF INCORPORATION

The undersigned, acting as incorporator(s) to a corporation pursuant to Chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:

ARTICLE I

Name

The name of the corporation shall be:

ARTICLE II

Principal place of business and mailing address

ARTICLE III

(Purposes)

The specific purposes for which the corporation is organized are:

The purpose of this Corporation shall be to cultivate, promote, promulgate and extend the teaching and precepts of Jesus Christ. To maintain a Biblical Christian Church, providing a place to worship, to conduct religious services for the youth in addition to providing religious training for missionaries. We will establish prison ministries, drug rehabilitation counseling facilities and a feeding program for the elderly and the needy, we will develop hospital and nursing home ministries for destitute and distressed men, women, and children. This is for all races, creeds, religions and sex, oriented to the organizations' principles.

ARTICLE IV
Manner of Election of Directors

The manner in which the directors are elected or appointed is as follows:

The Corporation shall be managed by the Board of Directors. The first Board of Directors shall consist of those persons elected by the Incorporators or named as the initial Board of Directors in the Certificate of Incorporation of the Corporation, and they shall hold office until the first annual meetings of members and until their successors have been duly elected and qualified. Thereafter at each annual meeting of members, the membership shall elect directors to hold office until the next annual meeting. Each director shall hold office until his successor has been duly elected and qualified.

ARTICLE V

Limitation of corporate powers

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes, unless limited as follows:

ARTICLE VIII

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in Section 501 © (3) and 170 (c)(3) and 170 (c) (2) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future law or to the Federal, State or Local Government for exclusive public purpose.

Said Corporation is organized exclusively for charitable, religious, educational and scientific purposes, including for such purpose, the making of distributions to organizations that qualify as exempt, organizations under Section 501 © (3) or the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).

Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income Tax under Section 501 © (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.
