ARTICLES OF INCORPORATION  
OF  
LOGOS INSTITUTE OF INTERNATIONAL MINISTRIES, INC

The undersigned, acting as incorporators of a corporation under the Not-for-Profit Corporation Act of State of Florida, adopt the following articles of incorporation for such corporation:

ARTICLE I

**NAME:** The name of the corporation is the **LOGOS INSTITUTE OF INTERNATIONAL MINISTRIES, INC.**

ARTICLE II

**DURATION:** The duration of the Corporation shall be perpetual.

ARTICLE III

**PURPOSE:** (A) The organization is organized as non-profit corporation exclusively for charitable, religious, educational and scientific purposes. To act as a resource to address the problems inherent in communities-at-large. These problems include, but not limited to poverty, high crime, substance abuse, AIDS outreach, child day care, etc. To provide education through seminars and workshops on family matters, fractured families, christian living, teenage pregnancy and parenting, child abuse, etc.

(B) In furtherance, but not in limitation of the foregoing charitable and educational purposes, the Corporation shall be empowered to solicit, collect, and receive monies and assets, and to administer funds and contributions received by grants deed, bequest or devise otherwise to acquire money, securities, property rights and services of every kind and description and to hold, invest, expand, contribute, use, sell or otherwise dispose of any monies, securities, property, right or services acquired for the purpose above mentioned.

The Corporation shall exercise all other rights and powers conferred upon corporations formed under the General Non-Profit Corporation Act of the State of Florida, provided, however, that the Corporation shall not engage in any activities or exercise any powers, including those specifically mentioned herein, that are not in furtherance of the specific and primary charitable and educational purpose of the corporation.

All of the foregoing purposes and powers shall be exercise exclusively for charitable and educational purposes in such a manner that the Corporation shall qualify as an exempt organization under Section 501 (c) (3) of the Internal Revenue Code of 1986.

(C) No part of the Corporation funds shall be inure to the benefit of any member, trustee, officer of the Corporation, or any private individual, except that reasonable compensation may be paid for services rendered to or for the Corporation affecting one or more of its purposes, and no member, trustee, officer of the Corporation, or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the Corporation. No substantial part of the activities of the Corporation shall be for carrying of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in or intervene in, including the publication or distribution of statements, any political campaign on behalf of any candidate for public office. Notwithstanding any other provisions of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on by a Corporation exempt from Federal and State income taxes under section 501 (c) (3) of Internal Revenue Code.

(D) Upon the dissolution of the Corporation or the winding-up of its affairs, its assets shall be distributed exclusively to one or more charitable, religious, scientific, testing for public safety, literary, or educational organization which would then qualify under the provisions of Section 501 (c) (3) of the Internal Revenue Code and its Regulations as they now exist or as they may be hereafter amended, or to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the Corporation is located, exclusively for such purposes or to such organization or organization as said Court shall determine, which are organized and operated exclusively for such purposes.

#### ARTICLE IV

**QUALIFICATION:** The qualification of the members and the manner of their admissions shall be regulated by the by-laws.

#### ARTICLE V

**OFFICE:** The location of the Corporation is in the County of Broward. The initial address of the registered office is 4180 SW 11th Street, Plantation, Florida, 33317. The name of the initial registered agent at such address is Scott Ustick.

#### ARTICLE VI

**TERRITORY:** The Corporation shall conduct its operation principally, within, but **NOT** limited to the United State of America and its territories and possessions.

ARTICLE VII

**OFFICERS:** The initial Board of Trustees shall consist of at least three (3) members. The names and address of persons who shall serve as Board of Trustees until first annual meeting and who will serve until their respective successors are elected at the subsequent meeting are as follows:


