ARTICLES OF INCORPORATION FOR LAKE MAGDALENE UNITED METHODIST CHURCH, INC. 98 JAN - 6 PM 4: 04

SECRETARY OF STATE TALLAHASSEE, FLORIDA

EARLY CHILDHOOD CENTER

The undersigned, acting as the incorporator of a non-profit corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation shall be LAKE MAGDALENE UNITED METHODIST CHURCH, INC. EARLY CHILDHOOD CENTER.

ARTICLE II. REGISTERED OFFICE ADDRESS

The principal place of business and mailing address of this corporation shall be 2902 Fletcher Avenue West, Tampa, Florida 33618.

ARTICLE III. PURPOSES

Section 1. The specific purposes of this corporation shall be to operate a churchrelated school and kindergarten facility on the premises belonging to and under the direction of Lake Magdalene United Methodist Church, Inc., and to provide a highquality age-appropriate education to the whole child in a Christian environment.

Notwithstanding any other provision of these Articles, this corporation shall not carry on any activities not permitted to be carried on by: (a) a corporation exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue Law, or (b) a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1954 or any other corresponding provision of any future United States Internal Revenue Law.

ARTICLE IV. DIRECTORS

There shall be twelve (12) directors of this corporation who shall be natural persons who are eighteen (18) years of age or older. The names and addresses of the individuals who are to serve as the initial directors are as follows:

ARTICLE V. MANNER OF ELECTION OF DIRECTORS

The directors shall be natural persons who are eighteen (18) years of age or older who hold the following positions:

- 1. Early Childhood Center Director
- 2. Senior Pastor of Lake Magdalene United Methodist Church
- 3. Early Childhood Center Child Care Coordinator
- 4. Early Childhood Center Teacher Representative
- 5. Member at large with child in or have had child in Early Childhood Center
- 6. Member at large with child in or have had child in Early Childhood Center
- 7. Member at large with child in or have had child in Early Childhood Center
- 8. Member at large with child in or have had child in Early Childhood Center
- 9. Member at large with child in or have had child in Early Childhood Center
- 10. Director of Christian Education at Lake Magdalene United Methodist Church
- 11. Chairman of the Finance Committee Lake Magdalene United Methodist Church
- 12. Chairman of the Trustees Lake Magdalene United Methodist Church

The Early Childhood Center Teacher Representative shall be elected annually by the teachers of the Early Childhood Center. The Finance Chairman and the Trustees' Chairman shall be elected annually by the Charge Conference of Lake Magdalene United Methodist Church. The Senior Pastor, Early Childhood Center Child Care Coordinator, and Director of Christian Education shall serve by nature of their professional relationship in their respective positions. Recommendations for Members at large of the Early Childhood Center shall be made annually by the Early Childhood Center Child Care Coordinator. Nominees will be nominated by the Nominations and Personnel Committee of Lake Magdalene United Methodist Church and elected by the Charge Conference of Lake Magdalene United Methodist Church.

Members at large shall serve 3 consecutive one year terms beginning July 1 and ending on June 30.

Of the five (5) members at large, two (2) shall serve an initial term of one (1) year, two (2) shall serve an initial term of two (2) years, and one (1) shall serve an initial term of three (3) years.

ARTICLE VI. OFFICERS

This corporation shall have a President, Vice President, Secretary, and Treasurer whose duties will be stated in Florida Statutes 617.0840 and 617.0841, and bylaws of the corporation.

Said officers shall be elected and appointed at an annual meeting of the Board of Directors of the Early Childhood Center.

ARTICLE VII. LIMITATION OF CORPORATE POWERS

The corporate powers of this corporation are as provided in Section 617.0302, Florida Statutes.

ARTICLE VIII. ASSETS AND EARNINGS

No part of the net earnings of the corporation shall inure to the benefit of or be distributable to its members, directors, officers, or other private persons, or to any other organization, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof.

ARTICLE IX. BYLAWS

The Board of Directors of the corporation shall adopt such bylaws for the conduct of its activities as it may deem appropriate from time to time. Upon proper notice, the bylaws, as so adopted, may be amended, altered or rescinded by a majority vote of those members of the Board of Directors present at any regular or special meeting called for that purpose.

ARTICLE X. DISTRIBUTIONS UPON LIQUIDATION OR DISSOLUTION

Upon dissolution of the corporation or upon a liquidation of its assets, whether voluntary or involuntary, or by operation of law, except as and to the extent otherwise provided or required by law, the net assets remaining after payment of all debts and obligations of the corporation and of all costs and expenses of such liquidation or dissolution, shall be distributed to Lake Magdalene United Methodist Church, Inc. In the event it no longer exists, then to the Florida Methodist Conference. If no such organization exists, then, at the discretion of Directors, the funds shall be distributed to an organization or corporation that qualifies under Section 501(c)(3) of the Internal Revenue Code of 1954, as it now exists or as it may be amended in the future.

ARTICLE XI. PROHIBITED ACTIVITIES

The corporation:

- (a) shall not attempt to influence legislation as a substantial part of its activities;
- (b) shall not allow any part of its net income to inure to the benefit of Directors, Officers, or Members of the corporation or to any other individuals, except in the furtherance of its Charitable Purposes;
- (c) shall not participate to any extent in any political campaign for or against any candidate for public office;
- (d) shall not conduct any activities not permitted to be carried on by organizations exempt under Section 501(c)(3) of the Internal Revenue Code of 1986 (the Code), or by any organization, contributions to which are deductible under Section 170(c)(2) of the Code;
- (e) to the extent the corporation is or may become a private foundation, within the meaning of Section 509 of the Code, the corporation shall not fail to distribute its income for each taxable year at such time and in such manner as to become subject to the tax on undistributed income imposed by Section 4942 of the Code;

(f) to the extent the corporation is or may become a private foundation, within the meaning of Section 509 of the Code, the corporation shall not engage in any act of self-dealing as defined in Section 4941(d) of the Code;

to the extent the corporation is or may become a private foundation within the meaning of Section 509 of the Code, the corporation shall not retain any excess business holding as defined in Section 4943(c) of the Code;

(h) to the extent the corporation is or may become a private foundation within the meaning of Section 509 of the Code, the corporation shall not make any investment in such manner as to subject it to tax under Section 4944 of the Code; or

(i) to the extent the corporation is or may become a private foundation within the meaning of Section 509 of the Code, the corporation shall not make any taxable expenditures as defined in Section 4945(d) of the Code.

ARTICLE XII. AMENDMENTS TO ARTICLES OF INCORPORATION

These articles of incorporation may only be amended at the initiation of the Lake Magdalene United Methodist Church, Inc., Early Childhood Center Board of Directors. The proposed amendment(s) must then receive the approval of the Lake Magdalene United Methodist Church, Inc., Early Childhood Center Board of Directors and approval by a majority vote at the Charge Conference of Lake Magdalene United Methodist Church, Inc. The Charge Conference is to be held immediately before or after a scheduled meeting of the Administrative Board of Lake Magdalene United Methodist Church, Inc.

ARTICLE XIII. COMMENCEMENT AND DURATION

This corporation shall commence to exist as of the date of filing of these Articles of Incorporation with the Secretary of State's Office, and shall exist perpetually thereafter until dissolved.
