The undersigned, acting as incorporator(s) of a corporation pursuant to chapter 617.0202, Florida Statutes, adopt(s) the following Articles of Incorporation:

**ARTICLE I
Name**

**ARTICLE III
Purpose(s)**

The specific purpose(s) for which the corporation is organized is(are):

The purpose of which the organization called Summerville Baptist Church, INC. is organized are exclusively religious, charitable, literary and educational within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding provision of any future United States Internal Revenue Law.

The purpose also shall be to cultivate, promote, promulgate and extend the teachings and precepts of Jesus Christ. In addition, to maintain a Biblical Christian Church, providing a place to worship, establishing other churches in other cities, states and international locations. Further, it shall be our purpose to establish, maintain and conduct schools for the religious instruction of the young. We will also perform other charitable works as: drug rehabilitation counseling, feeding the needy, programs for the elderly, and destitute and distressed men women and children. Our purposes are available to all races, creeds, and sexes.

ARTICLE IV
Manner of election of directors

The manner in which the directors are elected or appointed is as follows:

ARTICLE V
Limitation of Corporate powers

Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

ARTICLE VI
Dissolution

Upon dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c) (3) of the Internal Revenue Code of 1986, or corresponding section of any future Federal tax code, or shall be distributed to the Federal, state or local government for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of competent jurisdiction, of the county in which the principal office of the organization is then located, exclusively for such purposes.


