The undersigned, acting as incorporator(s) of a corporation pursuant to Chapter 617 Florida Statutes, adopt(s) the following ARTICLES OF INCORPORATION:

ARTICLE I  
NAME

The name of the corporation shall be:

CHURCH OF THE RISEN CHRIST, INC.

ARTICLE II  
PRINCIPLE PLACE OF BUSINESS & MAILING ADDRESS

The principle place of business and mailing address of this corporation shall be:

8421 Briar Leaf Court, Port Richey, Florida 34688

ARTICLE III  
PURPOSE(S)

The specific purpose(s) for which the corporation is organized is (are):

The purpose(s) for which *CHURCH OF THE RISEN CHRIST, INC.* is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

Notwithstanding any provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

To establish missions and parish churches for worship; parochial schools; schools of theology and Biblical studies to educate and train individuals for Christian service and the priesthood. And, to teach, live, and administer the sacraments under the authority of (The) Rev. Fr. Raymond H. Young, D.D., as Chief Executive Officer, and his successors.

ARTICLE IV  
MANNER OF ELECTION OF DIRECTORS

The manner in which the Directors are elected shall be as follows:

The Directors of this corporation shall be any member in good standing. The by-laws shall state the manner in which directors shall be appointed, together with the terms of office. The by-laws shall state the manner in which the the Chief Executive office shall be succeeded.

**ARTICLE V  
LIMITATION OF CORPORATE POWER**

The corporate powers of this corporation are as provided in section 617:0302, Florida Statutes, unless limited, are as follows:

Subject to the limitations contained in the By-laws, and any limitations set forth in the corporate not-for-profit laws of the State of Florida, this corporation, By-laws of the corporation may be made, altered, rescinded, added to, or new by-laws may be adopted, either by resolution, or by following the procedure set forth in the By-laws.

**ARTICLE VI  
DISSOLUTION**

Upon the dissolution of this corporation, assets shall:

Be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code or corresponding section of any future Federal tax code, or shall be distributed to the federal government, or shall be distributed to a state or local government for a public purpose. Any such assets not disposed of, shall be disposed of by the Court of Common Pleas (or its equivalent) of the county in which the principle office of the corporation is located, exclusively for such purposes, or such organization or organizations, as said court may determine, which are organized and operated exclusively for such purposes.
