**ARTICLES OF INCORPORATION**  
**OF**  
**A FLORIDA NONPROFIT CORPORATION**

**ARTICLE I - CORPORATE NAME**

The name of this corporation is A VERY PRESENT  
HELP MINISTRIES, INC.

**ARTICLE II - CORPORATE NATURE**

This is a nonprofit corporation, organized solely  
for general charitable purposes pursuant to the Florida  
Corporations Not for Profit Law set in Part I of Chapter  
617 of the Florida Statutes.

**ARTICLE III - GENERAL AND SPECIFIC PURPOSES**

(a) The specific and primary purposes for which  
this corporation is formed are to operate for the advance-  
ment of charity and education, and for other charitable  
purposes, by the distribution of its funds for such purposes.

(b) The general purposes for which this corporation  
is formed are to operate exclusively for such charitable  
and educational purposes as will qualify it as an exempt  
organization under Section 501(c)(3) of the Internal Revenue  
Code of 1954, or corresponding provisions of any subsequent  
federal tax laws, including, for such purposes, the making  
of distributions to organizations which qualify for tax-  
exempt organizations under that Code.

(c) This corporation shall not, as a substantial  
part of its activities, carry on propaganda or otherwise  
attempt to influence legislation; nor shall it participate  
or intervene (by publication or distribution of any state-  
ment or otherwise) in any political campaign on behalf  
of any candidate for public office.

#### ARTICLE IV - COMMENCEMENT AND DURATION

The corporation is to commence its corporate existence on the date of subscription and acknowledgment of these articles of incorporation and shall exist perpetually thereafter until dissolved according to law.

#### ARTICLE V - BOARD OF DIRECTORS

All corporate powers shall be exercised by and under the authority of, and the business and affairs of the corporation shall be managed under the direction of, the board of directors.

The corporation shall have six (6) directors initially. The number of directors may thereafter be increased or decreased from time to time in accordance with the bylaws of the corporation.

The names and street addresses of the initial directors who shall hold office until their successors, who shall be chosen at the first meeting of members, have qualified, shall be:

**ARTICLE VIII - BYLAWS**

The power to adopt, alter, amend or repeal bylaws shall be vested in the board of directors.

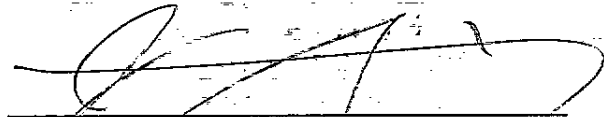
**ARTICLE IX - DEDICATION OF ASSETS**

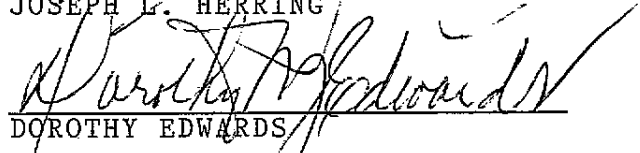
**ARTICLE X - DISTRIBUTION OF ASSETS**

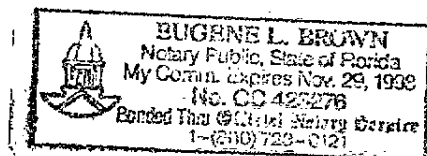

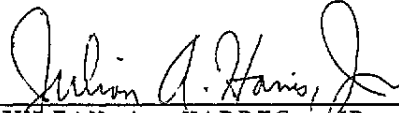
